Use appropriate techniques to encourage active participation in decision-making regarding such things as classroom rules, organization and topics of study which communicate a caring attitude and trust of students. Develop and implement a system for student recognition. Promote problem solving, cooperative negotiating skills and conflict resolution strategies. Apply appropriate consequences for inappropriate student behavior. Develop healthy self-esteem in students. Structure lessons that encourage risk-taking in learning. Model life-long learning.
- **2. Data management.** Maintain records for such things as student attendance, evaluations, report cards, discipline records, and documents required by the School Board or Department of Education and Culture using prescribed formats;
- **3. Leadership.** Actively pursue leadership roles in the school and promote leadership opportunities in the classroom.
