Speech-Language Pathologist K-12

Job Summary:

The Speech-Language Pathologist K-12 serves in the capacity to meet the developmental needs of children, through a Multi-Tiered System of Supports (MTSS) framework. The Speech-Language Pathologist K-12 uses a coaching model with strategies to help students develop new skills to share with parents, caregivers, and educational team members.

Essential Duties (May include, but not limited to):

- Assists in developing a Multi-Tiered System of Support (MTSS) to provide developmental educational experiences for children who may experience developmental delays.
- Demonstrates an understanding of the development of language and communication skills in students and coaching classroom staff in strategies and activities to improve language and communication skills.
- 3. Provides service coordination for speech and language supports.
- 4. Provides staff education and high quality professional development.
- 5. Collaborates with staff in planning educational interventions, assessments, literacy supports, and instructional strategies.
- 6. Attends and participates in district MTSS meetings as requested.
- 7. Compiles and maintains records, written reports and other documentation for students.
- 8. Works as a team member with instructional and ancillary staff to refer eligible students for speech and language services.
- 9. Works as a team member with instructional staff and parents/guardians to refer eligible students to outside agencies and other community resources.
- 10. Participates in child assessments and interprets evaluation results for families.
- 11. Develops, maintains, and documents student's Plan of Care and related service provisions.
- 12. Provides in-service information and training to staff for the integration of language development into daily classroom instruction.
- 13. Consults, counsels and collaborates with parents, school personnel, students and appropriate community agencies regarding behavioral and educational concerns developed in a multi-tiered system of support.
- 14. Consistently models Win-Win leadership
