**We will be using a variety of supplemental materials to target mathematical learning gaps and increase math proficiency. We plan to run this in the morning and afternoon so students needing math and ELA can do both. Instructional materials will be provided. Class sizes will be limited to about 15 students per teacher.**

- Master's Degree preferred

- Ability to successfully pass a background check
- Any alternatives to the above qualifications as may be appropriate and acceptable to the Superintendent or his designee
