**<u>SUMMARY</u>**: Counsels students and provides educational and vocational resources/guidance services by performing the following duties.

**ESSENTIAL DUTIES AND RESPONSIBILITIES**. Other duties may be assigned. This list is not exhaustive.

Provides support services for students in the areas of academic programs, team teaching, registration, course planning, school rules and other matters.

Assesses and counsels students based on observations, conversations and test results.

Provides personal counseling for students, families and groups to help them learn greater self-understanding, acceptance of responsibility and better decision-making skills.

Provides group counseling for interaction, communication and support skill development when appropriate.

Interprets post-high school opportunities and available information regarding career, college, military and life style decisions.

Administers tests and interprets results in areas such as organization, memory skills, aptitude and preferences.

Evening conferences for groups, test interpretations with parents, new student orientation/with parents.

### System Support

- 1. Plan and evaluate the counseling program.
- 2. Promote a positive working relationship with students, staff, and members of the community.
- 3. Pursue continuous professional growth by keeping current with educational developments and literature in the field of school guidance.
- 4. Develop and maintain a library of pertinent information available to students, parents, and staff.
- 5. Perform other tasks and assume other responsibilities as may from time to time be assigned.
