SUMMARY OF PURPOSE

To provide occupational therapy services to students in LIU 12.

ESSENTIAL REQUIREMENTS

- Bachelor's degree in Occupational Therapy required; Master's degree preferred.
- NBCOT certified and Pennsylvania state license in Occupational Therapy required
- Valid Pennsylvania driver's license
- Must provide prompt, professional and courteous responses to all inquiries from internal and external customers.
- Must possess proactive problem-solving skills

ESSENTIAL FUNCTIONS

- Assesses student's occupational participation, occupational performance areas, and occupational
 performance components which are relevant to the student's access to FAPE.
- Participates in educational MDE and IEP processes for identification of students' strengths, needs, exceptionality, goals, objectives, and determination of service delivery requirements necessary for students to benefit from their individualized educational programs.
- Designs and implements occupational therapy intervention programs that fulfill the student's IEP or the Service Agreement.
- Provides ongoing management of the occupational therapy program, including documentation, communication, record keeping, in-service education, and maintenance of supplies and equipment within the occupational program.
- Provides indirect supervision of a certified occupational therapy assistant that is directly assigned to him/her within the occupational therapy program.
- Collaborates with members of the student's educational team.
- Develops a schedule which reflects services in compliance with the needs of all students on the therapist's caseload.
- Adheres to the established work schedule through regular and consistent attendance.

- Contributes to the effective team management of all problems, issues and opportunities.
- Observes all LIU requirements governing FERPA, HIPAA, and any LIU policies on FERPA and/or HIPAA's policies and notices of privacy practices.
- Develops and presents training sessions (synchronous or asynchronous) to support parents, families, school personnel in providing identified supports for students requiring OT services.

DIVISION/ORGANIZATION

- Keeps current with related technology and developments that impact the division and the organization.
- Makes decisions consistent with the LIU mission and core values, establishes and maintains effective communication and positive relationships within the LIU, and fosters professional development of LIU staff.
- Contributes to the effective team management of all issues and opportunities within the LIU by modeling the
 qualities of an LIU Team member (being versatile, ethical, transparent, team-oriented, innovative,
 transformative and collaborative; valuing each team member; and understanding the importance of customer
 service.)
- Understands organizational development and change principles, and applies these principles to promote improvement within the Division.
- Performs other functions as assigned by the Division Director.
