### **POSITION GOAL:**

Supervise students during lunch period to ensure a safe and orderly lunch/recess period. Assist with set-up and clean-up before and after lunch.

#### **ESSENTIAL FUNCTIONS:**

- 1. Knows and adheres to school policies and procedures.
- 2. Knows and adheres to the components of the school-wide management plan/PBIS framework.
- 3. Assists with lunchroom/playground set up and clean up before and after lunch.
- 4. Facilitates structured play.
- 5. Ensures a safe and respectful environment during recess, serving lines, while eating and during lunchroom dismissal.
- 6. Supervises students in assigned areas and implements safety rules and procedures.
- 7. Assists students in securing trays, food, seating and dismissal.
- 8. Circulates among students on the playground and in the lunchroom to provide assistance or to resolve minor issues.
- 9. Helps to maintain discipline on the playground, in the lunchroom and in the hallways.
- 10. Recognizes and rewards positive behavior.
- 11. Responds appropriately in stressful situations.
- 12. Shows consistency with students and good follow-through with discipline and positive reinforcement.
- 13. Communicates effectively with students and staff.
- 14. Required to report all student injuries, accidents, illnesses and discipline issues to the appropriate authority immediately, or as soon as reasonably possible.
- 15. Accepts suggestions in a positive manner and makes needed improvements.
- 16. Maintains confidentiality of student information in the school and in the community.
- 17. Other duties as assigned by supervisor.
